**SUPPRESSIVE PERSON DECLARE
ON
DORTHE MAI**

Dorthe Mai, from Denmark, is hereby declared a Suppressive Person. As per HCO PL 7 March 1965RB SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS, a suppressive person is **“One that actively seeks to suppress or damage Scientology or a Scientologist by suppressive acts.”** – LRH

Per HCO PL 7 March 1965RB SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS **“Suppressive persons or groups relinquish their rights as Scientologists by their very actions and may not receive the benefits of the Codes of the Church.”** - LRH

Dorthe has requested a refund of donations given to the Church for services started and services on account and this has been given. While requesting her refund she on several occasions threatened with legal action against the Church if certain requirements she made were not fulfilled.

She announced to certain staff members, that she was leaving the Church and no longer wanted to be a Scientologist.

When help was offered to Dorthe to resolve the matter on standard Church lines, she refused to do so.

Dorthe has committed the following Suppressive Act:

1. DEMANDING THE RETURN OF ANY OR ALL FEE PAID FOR STANDARD TRAINING OR PROCESSING ACTUALLY RECEIVED OR RECEIVED IN PART AND STILL AVAILABLE BUT UNDELIVERED ONLY BECAUSE OF DEPARTURE OF THE PERSON DEMANDING.

Any certificates and awards issued to Dorthe are hereby cancelled. Any license she may have signed to use the marks of Dianetics or Scientology are hereby also cancelled and she may not use the marks in any manner whatsoever.

Should she come to her senses and recant, she is to do the steps A-E of HCO PL 7 March 1965RB, “SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS”.

Her only terminal is the International Justice Chief via the Continental Justice Chief.
